1. University Chancellor Update

1.1 The Vice-Chancellor advised Nominations Committee that the Chancellor Appointment Committee met recently to discuss the shortlist and arrived at a preferred candidate. The Vice-Chancellor and Chair of Council would move forward with the next stage of the process.

2. Membership of Council 2020/21-2021/22 and Appointment of Council Members.

- 2.1 Nominations Committee **discussed** the membership of Council and **agreed** to recommend Salam Katbi and Glenn Woodcock for re-appointment as Independent Members to Council.
- 2.2 The Committee further noted the following membership updates:
 - 2.1.1. Sir John O'Reilly will step down as an independent member in July 2021.
 - 2.1.2. Dr Barrie Cooper has been appointed as a Senate Representative on Council.
 - 2.1.3. Senate will coordinate the process to replace Professor Andrew McRae following his term ending in July 2021.
 - 2.1.4. The result of the election for a replacement Class IV member (Professional Services Representative) would be announced later in June 2021.
 - 2.1.5. The outcomes of elections for Student Representatives have been announced as Lily Margaroli (Students' Guild) and Steven Preece (Falmouth and Exeter SU).
- 2.3 Nominations Committee **discussed** the appointment of Council members in response to **noting** one vacancy from August 2021. It was **agreed** that the Vice-Chancellor would reach out to the **agreed** candidates as well as general collation of a list of candidates for future reference.

3. Membership of Council Committees - Succession Planning

- 3.1 Nominations Committee **discussed** membership of Council committees and succession planning, including changes to the number of independent members on internal governance committees.
- 3.2 It was **noted** that the Terms of Reference of the Council Investment Review Committee would need to be agreed by the Committee.

4. Apprenticeship Programme

4.1 It was **agreed** by the Committee that a formal proposal for an internal internship/development opportunity in HE governance would need to be brought to Council, with the potential for a single position being available for one year at a time to be explored.

5. Internal Audit Recommendations

5.1 The Committee **discussed** the internal audit recommendation, and **agreed** an expansion on induction day training to include one-to-one meetings with key University stakeholders would help enhance the onboarding of new members.

6. **Dual Assurance Portfolios**

6.1 Dual Assurance portfolios were **noted** for the next academic year (2021-22).

7. Membership of Trusts 2021-22

- 7.1 The Committee **agreed** to recommend the following appointments to Council:
 - 7.1.1. Jane Chafer as a trustee (3-year term) for Cambourne of Mines until 2024.
 - 7.1.2. Re-appointment of Pamela Freeman as a trustee (3-year term) for the Devon Educational Trust until July 2024

8. Council Members Skills Matrix

8.1 The Committee **discussed** the need to simplify the skills matrix and **decided** that members be limited to three skills each (basic, moderate and expert).
