May 2023



INTRODUCTION

Being a civic university means being authentically linked to a place and a community, responsive to its needs and committed to its success.

Falmouth University and the University of Exeter Cornwall, while distinct in their institutional strategies and specialisms, share a strong commitment to supporting Cornwall and the Isles of Scilly's growth and prosperity. This has been the driving force for developing the Universities' presence in the region over the last two decades, creating new economic and educational opportunities and catalysing the region's knowledge and skills. As major local employers, as well as a dynamic hub for pioneering education, research and knowledge exchange, the Universities play a vital role in the economic, social and cultural life of the region, working both separately and together on civic activities.

This Civic University Agreement is an opportunity to advance and amplify the impact of the Universities' shared and complementary strengths, embedding partner and community collaboration into their strategic decision making.

Thousands of residents helped shape *Together* We Can: The Cornwall Plan 2020-50 and this has informed our thinking as we drafted this Agreement. Developed through public and partner engagement, this Agreement sets out four shared key priorities:

A shared commitment to create healthy, safe and resilient communities where people live well for longer.





GREEN FUTURES CORNWALL AND ISLES OF SCILLY

Protecting and enhancing the environment is crucial for the future of our local communities and for our global climate and ecological survival.

In Cornwall and the Isles of Scilly, with its rich and remarkable natural world all around us, the need to act for the environment is profoundly clear.

The Universities have both committed to plans to achieve carbon neutrality and to support Cornwall and Isles of Scilly's transition to net zero. But more than that, both institutions understand that as places of advanced research and knowledge, and as educators of future global innovators, business leaders and entrepreneurs, we have an important role in driving policy and behaviour change and providing new ideas and solutions to difficult global problems.

Cornwall and the Isles of Scilly have exceptional natural capital assets alongside unique strengths in minerals and mining expertise critical for the transition to net zero. Growth in our green and blue economy will support new jobs, while innovations in renewable and marine technology, exploitation of our critical mineral deposits will create new business opportunities. Additionally, the acceleration of the adoption of circular economy approaches, initiatives to promote behaviour change and new creative innovations to pivot Cornwall's dominant industry sectors to sustainability-led practices will put Cornwall at the forefront of the decarbonised national economy.

Cornwall and the Isles of Scilly have deep and persistent inequalities in health and wealth.



FAIR FUTURES CORNWALL AND ISLES OF SCILLY

Cornwall and the Isles of Scilly have received significant investment over the last three decades to develop the economy and enable it to prosper. While much has been achieved, the returns have not been felt by everyone.

The Civic University Agreement will support efforts to tackle inequality and exclusion, including through widened participation in training and skills, increased access to cultural and educational programming, raised aspirations, improved social mobility and narrower attainment gaps.

Our activity will be inclusive and consultative, strengthening community engagement in our work, ensuring we are a good neighbour to local residents, facilitating community use of our spaces and using our considerable spend with third party suppliers to support local businesses and jobs.

SETTING OUR PRIORITIES, MEASURING OUR IMPACT AND GROWING OUR PARTNERSHIPS

This Agreement will be overseen by a Civic University Partnership Board.

To ensure that this Agreement provides real impact for people and communities in Cornwall and the Isles of Scilly, this document will be underpinned by an annual programme of work which will be formally reviewed at bi-annual Board meetings.

To embed collaborative community engagement and ensure that the priorities of the Partnership are evolving in line with the priorities of the community, we will host three workshop-style engagement sessions yearly with partners and local stakeholders to inform and update our civic ambitions and to identify fresh priorities for the period ahead.

We intend that this regular cadence of public engagement and a clear planning and reporting cycle will ensure that we are transparent and accountable, and that the Agreement continues to evolve in an agile, organic way, responsive to the changing needs of our community.

As our collaboration develops, we will work with more stakeholders from across the civic landscape and we hope that we will engage additional partners as formal signatories to this Agreement.
