

Undergraduate Global Excellence Scholarships 2024/25

The Undergraduate (UG) Global Excellence Scholarships 2024/25 recognise high academic achievement and ambition.

The award amount is £7,500.

These awards are available to International fee status applicants (including any EU applicants required to pay International fees in 2024/25) who already hold an offer to study an eligible UG programme at the University of Exeter beginning in the 2024/25 academic year.

Applicants progressing from INTO University of Exeter International Foundation are not eligible.

Applicants for entry to year two of an Undergraduate degree programme are not eligible.

Scholarships are available for campus-based UG degrees in the following departments (including study abroad and industrial experience variants):

Ineligible Undergraduate programmes are: all Flexible Combined Honours; BMBS Medicine; Degree Apprenticeships; Dual LLB/Juris Doctor (JD) with the Chinese University of Hong Kong; LLB Law (for Brickfields Asia College only) LLB Engineering and Law (HKUST); Legal Practice Course; Graduate Law LLB.

Scholarship recipients are selected on:

- Academic merit, based on the information applicants have supplied in their UCAS application. The scholarship minimum academic criteria are below:

Faculty	Departments/subject areas
Environment, Science and Economy	Departments excluding the Business School: At the discretion of the faculty
	The Business School (Departments/subject areas of Economics, Finance and Accounting & Management): Minimum A*AA or above at A Level, or equivalent
Health and Life Sciences	Minimum AAB or above at A Level, or equivalent
Humanities, Arts and Social Sciences	Minimum AAB or above at A Level, or equivalent

- The ability to demonstrate the following as part of the application process: academic ambition; future career ambitions; a genuine need for the scholarship and how this will support your ambitions; a sense of social responsibility and willingness to engage with the Exeter community.

To apply, you must complete and submit an online application form, via the Funding database entry, including a personal statement of up to 300 words that responds to the following questions:

- What is your interest in your chosen programme of study and what are you hoping to learn?
- What are your future ambitions and how will your studies help you to achieve them?
- What would being awarded a Global Excellence Scholarship mean to you – what difference would it make?
- As a Global Excellence Scholar, how might you act as an ambassador for the University?

You may only make one application for the Global Excellence Scholarship per eligible programme for which you are holding an offer. There will be two rounds of applications during the year. You should apply at the earliest opportunity following receipt of your programme offer. Duplicate applications will be disregarded.

Application rounds:

Round One

Opens: 25 September 2023

Closes: 9 February 2024

Decisions communicated by: 9 March 2024

Round Two

Opens: 26 February 2024

Closes: 26 April 2024

Decisions communicated by: 25 May 2024

The deadline for Round 2 of the Global Excellence Scholarships 2024/25 scheme has been extended from 26 April 2024 to 24 May 2024. Eligible candidates who apply by the original deadline of 26 April 2024 will receive their decision notification by 25 May 2024 as planned. Eligible candidates who apply between 27 April 2024 and 24 May 2024 will receive their decision notification no later than 15 June 2024ⁱ.

Applications will be checked initially to ensure that the eligibility criteria have been met. Applications will then be considered by a nominated panel within the faculty. Applicants will be notified of the outcome of their application by email by the relevant date indicated above.

You cannot receive more than one scholarship from the University of Exeter; if you are eligible for multiple scholarships you will be awarded whichever scholarship has the higher value. If your tuition fees will be financed by an external body (such as an overseas government or a partner Institution) with whom the University has a shared financing agreement then this award may be invalidated or superseded with a different fee arrangement.

If you expect to receive funding from a charity this may also make you ineligible to receive this scholarship.

Self-funded students joining the University through an institutional progression or articulation agreement where a tuition fee discount is applied are not eligible for this scholarship.

It is your responsibility to inform us if you are in receipt of any external funding prior to enrolment; please email a copy of the award letter to admissions ug-ad@exeter.ac.uk

If you defer your 2024/25 offer or change fee status then your scholarship offer will be invalidated.

In the event that you withdraw or interrupt your studies post enrolment then the University Finance regulations at that date will apply as regards any repayment or other requirements:

By applying for this scholarship you are agreeing to your personal details being shared with the scholarship panel members.

Please note that if you are successful and accept this award, you may be asked to provide a photograph and written or video profile to appear in publicity material relating to scholarships and/or study at the University of Exeter.

This scholarship will be awarded as a reduction in tuition fees; it cannot be paid as cash or attributed to other charges such as accommodation fees. It will be automatically deducted from your first year tuition fees following enrolment. If you choose to pay your tuition fees in instalments, the award will be deducted from the total annual tuition fee and the remaining balance split accordingly.ⁱⁱ

This award is for one year only and is not recurrent for subsequent years of study.

ⁱⁱ Tuition fees deduction/s due are applied to your student account and show in your online statement within the first four weeks of study. Any awardees studying part time (under the relevant visa regulations) will receive the full Scholarship deduction in their first year.
